LANDFILL HOURS CHANGES – OCTOBER 1, 2009

**MONDAY, WEDNESDAY, FRIDAY, SATURDAY
11:00 A.M. – 3:00 P.M.**

PLEASE REMEMBER THAT ALL LOADS GOING TO THE LANDFILL MUST BE SECURED OR TARPED TO KEEP DEBRIS FROM FALLING OFF AND LITTERING THE ROADWAYS AND DITCHES.

PLEASE ENSURE THAT YOU STOP AT THE GATE OF THE LANDFILL AND REPORT TO THE SUPERVISOR ON DUTY. SHE WILL ADVISE YOU WHERE TO EMPTY YOUR GARBAGE – BE IT THE GENERAL GARBAGE PIT, CARDBOARD TRAILER, WOOD PILE, COMPOST PILE OR METAL AREA. FAILURE TO REPORT TO THE SUPERVISOR OR NOT SEPARATING YOUR REFUSE PROPERLY MAY RESULT IN YOUR LANDFILL PRIVILEGES BEING SUSPENDED.

CARDBOARD IS NOT TO BE PLACED IN THE GENERAL GARBAGE PIT. THERE IS A TRAILER LOCATED ADJACENT TO THE GENERAL PIT FOR CARDBOARD RECYCLING ALONG WITH BINS FOR PAPER, TIN AND MILK JUGS.

LANDFILL USERS ARE REMINDED THAT BURNING BARRELS ARE NOT ALLOWED.

PROVINCIAL TOILET REPLACEMENT REBATE PROGRAM:

Saskatchewan homeowners may qualify for a \$50.00 per eligible toilet replacement rebate if the following requirements are met:

1. The new toilet must be CSA-approved with a flush volume of 6 litres or less and must replace a toilet with a flush volume of 13 litres or more.
2. The new toilet is purchased after Jan. 1, 2009. The original receipt(s) must be submitted with the application. A duplicate receipts printed by your retailer will not be accepted.
3. A toilet replacement rebate under this program cannot be combined with a similar rebate through the Saskatchewan EnerGuide for Houses Program.
4. The home must have been built prior to January 1, 2009. This rebate will not be available to homeowners building new homes after this date.
